1.1 Access to the application website

To start the application process, the candidate must access the link:

- <u>https://fenix.igot.ulisboa.pt/accountCreation</u> **if you were never a student** at IGOT;
- <u>https://fenix.igot.ulisboa.pt/</u> if you are or were a student do IGOT in this case you must login with your *campus* credentials (if you don't remember your *campus* IDs, you must recover them at <u>https://utilizadores.campus.ulisboa.pt/ULUsersApp/reset/forgotPassword.seam</u>) and go to <u>point 1.3</u> of this manual.
